A note about Trailers and Sheds

Remember that when constructing something on your property, whether it be a room addition or Ramada, it must be approved by the architectural review committee. A friendly reminder that storage buildings "...shall be walled in or kept screened by adequate planting, walls or other means in such manner as to conceal them from the view of the neighboring lots, streets, or from the view of the golf course property."

Also, "No temporary house or trailer... shall be placed or erected on the lots..." Please remember that if you choose to keep a recreational trailer or any other type of trailer on your lot it must be stored OUT OF SIGHT in either your garage or in your backyard so as not to be seen from the street or by your neighbors.

49er Traffic Safety Update

Many of our residents may have noticed improvements made to the ninety degree turn adjacent to the driving range on Forty Niner Drive. This was done partially in response to the recent vehicle accident and as part of the regular maintenance on Pima Country roads. Specific improvements made by Pima County at no cost to the homeowners association were:

- Repainting of the solid white and double yellow lane markings with reflective paint
- Installation of raised reflective markings along the centerline of the curve
- Clearance of the overgrown vegetation on the inbound section of the road
- Installation of reflective poles on the outside of the turn

Some safety improvements are possible working through our local representative while others must go through the Pima County Department of Transportation (PCDOT). For issues regarding speeding and cut-through traffic, or a localized issue that affects only a portion of the development, a neighborhood committee must be formed for the affected area to work directly with Pima County DOT. For a development the size and shape and road configuration such as ours, we would need representatives in the west, central and eastern part of Forty Niners to coordinate issues specific to their portion of the neighborhood with PCDOT. Due to Pima County policy, the homeowners association is not allowed to deal directly with PCDOT on specific projects. We are looking for three representatives from the neighborhood to coordinate with PCDOT and the homeowner's association to make our roads as safe as possible for all residents and visitors.
